

## BJANA ELECTION COMMITTEE (EC) ANNOUNCEMENT OF BJANA ELECTIONS JAN-2024 - DEC-2025

As per the BJANA By-laws, the election of members of the Association's Executive Committee for the period Jan 2024 - Dec 2025 will be held for "a team" that will consist of the positions listed in the table below. The voters will nominate a team of nine candidates (*see the Nomination Form attached below*) consisting of the President, Vice-President, Secretary, Joint Secretary, Treasurer, and four Executive Members. The election will be held among the nominated teams.
